are rack-mounted, and Sheriff Casey Goetz has no problems with the arrangement, as long as there is enough room to store extra tables.

The third action item was an update to the "Memorandum of Understanding" between LeeCARES and Lee County. ARES members will be granted access to the equipment in the ARES room to use it when activated by the Lee County judge, emergency coordinator, or sheriff during an emergency or disaster.

Also, when the EOC has not been reserved for other use by the sheriff or the county, ARES now has permission to use room for maintaining the equipment, training members, and other activities. The sheriff will be provided a schedule of events in advance for his approval.
